**Association of State Floodplain Managers Conference in Reno,
Nevada**

The 32nd annual Conference of the Association of State Floodplain Managers (ASFPM) was held from May 18-23, 2008.

Over 1,300 floodplain management professionals from a wide array of disciplines attended the conference. There were important speakers at the plenary sessions. Small group panel discussions and meetings created a forum for diverse opinions. There were also seminars, trainings, and field trips. The vendors had lots of exhibits and lots of free information to give away. In the evenings social events created great networking opportunities.

Floodplain management officials from Kansas were able to attend this important conference in part because of funds available from Kansas. When asked about their experiences at the ASFPM Conference these are some of the responses by some local officials from Kansas.

Judy Freeman, Crawford County floodplain manager: "I totally enjoyed the entire conference. Meeting people from different states and learning that our problems are all the same and getting ideas how they handle in-office procedures to utilize and make the program work more efficiently. The best class I attended was a workshop on Wednesday put on by AMEC. It gave me insight as to how to prepare for a flood (and other) disasters in a 24-hour time frame and what to do after the flood from 48 hours up to a few weeks. This was a very good seminar. I would attend more workshops like that."

Peggy Sneegas, City of Overland Park floodplain manager: "The conference helped me with my CRS application and gave me ideas about updating our flood plain management ordinance."

Sheila Dale, Osage County floodplain manager: "The knowledge that I came home with will make my job easier and I am starting to understand all the layers that are involved with the NFIP, and how each has an important role. I see that we are not educating the public and the local official in the job that we do, and why it is important (to educate). The networking also has a value in the fact that it gives us more resources to ask questions and learn. I like the fact that individuals from CRS were there, and that I was able to sit with them and talk to them about the program. I am also a big fan of hands-on learning, because I believe that I retain more in those classes. I am also looking to expanding the library in the office and the public library. The CRS information has given me other ideas to improve the department. This conference has also given me the challenge to continue to gain knowledge in the field."

Funds available to attend the ASFPM National Conference June 7-12, 2009 in Orlando, Florida

The 2009 Association of State Floodplain Managers National Conference, “*Green Works to Reduce Flood Losses*”, will be June 7-12, 2009 in Orlando, Florida. This conference is an excellent opportunity for Kansas floodplain managers to receive premier training on mapping technologies, on adopting new flood hazard maps, and to discuss topics directly related to mapping and map modernization. The conference will be attended by nearly 1,300 floodplain management professionals and officials.

To help you attend this important event, the Division of Water Resources has funds from FEMA’s map modernization management support grant and will provide up to \$1,200 each for up to ten community officials to help defray the cost of attending this conference.

Lessons Learned In Chapman

A tornado struck the City of Chapman in Dickinson County on June 11, 2008 . Damage was minor for some structures while others were completely demolished. It was clear from the beginning that many homes would be deemed substantially damaged.

The City of Chapman quickly began a process to inform residents of substantial damage requirements. Information packets were distributed and public meetings were held within days of the event.

The eastern and southern parts of Chapman are all special flood hazard area (SFHA). The flooding sources are Chapman Creek on the east and the Smokey Hill River on the south side. The path of the tornado in Chapman began at the southwest part of the city just where the flood zone AE begins and continued northeast. Numerous structures in the SFHA were damaged. If a building in a SFHA is substantially damaged by any means, it must be flood protected when it is rebuilt. For a residential structure, this usually means that it must be elevated so that the lowest floor is one foot above the base flood elevation. Other options are demolition or relocation. For a non-residential structure, an additional option of floodproofing can be allowed if certified by a registered professional engineer or architect.

It was important to not allow substantially damaged buildings to be rebuilt without meeting the elevation or floodproofing requirements. Staff from Division of Water Resources and volunteers from Kansas Association of Floodplain Managers worked in Chapman to explain the regulations to homeowners, business people, and school officials. Many property owners did not want to fill in basements that had saved them from the tornado.

A team from FEMA helped make the residential substantial damage estimations for the City of Chapman. More than 50 structures were determined to have received enough damage to be identified as substantially damaged. Substantial damage requirements affected homes as well as schools and churches. The City of Chapman notified owners of the identified properties soon after the damage estimates were finalized. It was important that the city officials made that information available as soon as they could.

Disaster Declaration FEMA-1776-DR was declared for Kansas on July 9, 2008 . This declaration was for Chapman and all other Kansas counties affected by severe storms, tornadoes and flooding that took place between May 22, 2008, and June 16, 2008. Declaration FEMA-1776-DR made public assistance available. Individual assistance would not be available. Hazard Mitigation Grant Program funds may be available in Chapman to help individuals as long as certain criteria are met.

Hazard Mitigation Grant Program funds can be awarded to a community to help property owners with the cost of elevation, construction of a safe room, or to build a shelter. Such grants can happen only if the community agrees to partner in the process and the community has a hazard mitigation plan in place. Dickinson County is working on a hazard mitigation plan at this time.

The tornado in Chapman emphasized the need for early communication. It also became clear that it is important to get hazard mitigation planning done before disasters occur. Disasters like the Chapman tornado can occur at any time.
